The Voice and Influence Partnership (VIP) membership is growing

In the last year our work has meant that more people from communities who are not always well represented in local decision making processes – those who are older, from minority ethnic communities, from different faiths, identify as LGBTQ+ or identify as disabled – have been able to have their say about the big issues in Bristol. This has included transport, the Council budget, homelessness, air pollution and changes to the library service.

We are working with delivery partners Bristol Older People's Forum, OTR Freedom (LGBTQ+), WECIL (disability), Centre for the Deaf and Hard of Hearing, MAG Consulting (BME), Bristol Multi Faith Forum and advisory partners SARI and Bristol BME Voice, to increase the voice and influence our members have on Bristol City Council consultations.

Healthwatch partnered with Swindon
Advocacy Movement (SAM) to carry out
Enter and View. We did this to ensure
mainstream and specialist
services are meeting the needs of
people with learning disabilities or
autism in Swindon.

Visits took place at six GP surgeries and two dental practices. The recommendations were made by quality checkers with 'lived' experience of having a learning disability or autism and were produced in 'Easy Read.'

Thanks to our Healthwatch volunteer quality checkers, the services we visited have taken steps to become more accessible.

Dialogue

The Dialogue team have been involved in a range of projects to improve inclusion, understanding and collaboration across the health and wellbeing system in Bristol, North Somerset and South Gloucestershire (BNSSG).

Across BNSSG we've supported a review of existing mental health services and helped lead a pioneering NHS England-funded project to strengthen co-working between the Voluntary, Community and Social Enterprise (VCSE) sector and Healthier Together, our regional Sustainability and Transformation Partnership (STP).

Most recently we've been chosen by the West of England Academic Health Science Network (WEAHSN) to deploy a web platform called HYVR ('Have Your Vision Realised') for professionals, service users and members of the public to co-create new solutions in the field of health and social care health and social care

We're involved with Better Care Stronger Communities, reviewing existing mental health services, the frailty strategy and Healthier together. We are also working alongside West of England Academic Health Science Network (WEAHSN) on a web programme which aims to bring solutions to some of the challenges in our sector through professionals, service users and members of the public working together.

We were incredibly proud that our work was recognised at the national Healthwatch Awards in 2018. We were awarded 'runners up' for the work we have done with The Hive (Avon), a local charity for people with a learning disability.

Through this project, funded by the South Gloucestershire's Learning Difficulties Partnership Board, we recruited and trained six people with learning disabilities to carry out enter and view visits to a Minor injuries Unit, two GP surgeries, a Day Centre and an Accident and Emergency Department.

The volunteers' unique insight and recommendations for change have led to
